A. AGREEMENT

E. COMMISSION EARNINGS

2. The Parties are deemed to be independent contractors only and can not be seen as an employment contract in any way.

G. CONFIDENTIALITY

1. All terms and conditions of this Agreement and any materials provided during the term of the Agreement must be kept confidential, unless legally required to disclose.
2. This section will remain in effect even after the termination of this Agreement.

H. TERMINATION

1. This Agreement may be terminated in the event of a breach of this Agreement, or at any time by providing written notice to the other party 30 days prior to termination.
2. Upon termination, the Agent will return all Company products and/or any other content at his/her earliest convenience, but not beyond 7 days after termination.

I. REPRESENTATION AND WARRANTIES

Both Parties represent that they are fully authorized to enter this Agreement, and the performance of their responsibilities will not violate any laws or rights of others, or any other agreements.

J. SEVERABILITY

If any provision of this Agreement is found unenforceable, the remaining provisions will remain in effect in accordance with the Parties' intention.

K. AMENDMENTS

Any amendments to this Agreement must be in writing and signed by both Parties to be enforceable.

L. ENTIRE AGREEMENT

This Agreement contains the entire understanding between the Parties with respect to its subject matter and supersedes all prior agreements and understandings.
